having all dogs returned for taxation, but the imposition of these duties upon the County Game Warden is cumulative and shall not be construed to relieve any and all other officers now charged by law with the performance of any duty in connection with the subject matter. Of every tax so collected by the Treasurer on dogs returned within the time prescribed by law, the Treasurer shall receive $12\frac{1}{2}\phi$ and the County Game Warden $12\frac{1}{2}\phi$. On every such dog returned or caused to be returned after the prescribed limit, the County Game Warden shall receive the sum of $37\frac{1}{2}\phi$, to be paid when such tax has been collected by the Treasurer. In the event that the tax is not collected by the Treasurer, the fees herein provided for the County Game Warden shall be paid out of any fines that may be imposed and collected on account of a violation of the penalty provisions of the statute applicable thereto.

§ 2. All Acts or parts of Acts inconsistent herewith are hereby repealed.

§ 3. This Act shall take effect immediately upon its approval by the Governor.

AN ACT to Authorize and Empower the City Council of the City of Beaufort to Secure Real Estate for Aviation Purposes and For Golf Courses, and to Enter into Agreements Incident to the Use Thereof.

Section 1. City of Beaufort May Acquire Lands for Aviation Field or Golf Course.—Be it enacted by the General Assembly of the State of South Carolina: The City Council of the City of Beaufort is authorized and empowered to secure by purchase, condemnation, lease, gift or otherwise, any land or lands, within or without the City of Beaufort, for the purpose of establishing and maintaining an aviation field or fields, and a golf course or courses; and to secure the services of any person or persons necessary to the operation of the same.

§ 2. **City of Beaufort May Enter Into Agreements Incident to the Use of its Rights.**—The City Council of the City of Beaufort is authorized and empowered to sell, lease or give to the

United States Government, or any authorized department thereof, any land or lands now owned or under lease, subject to such lease, or may hereafter be acquired or leased, to be used as an aviation field; and to enter into any agreement or agreements with the United States Government, or any department thereof, and any corporation, association or person incident to the establishment, maintaining and operation of an aviation field or fields and golf course in Beaufort or its vicinity.

§ 3. All Acts or parts of Acts inconsistent herewith are hereby repealed.

§ 4. This Act shall take effect immediately upon its approval by the Governor.

AN ACT to Provide for the Compensation of Certain Officers of Darlington County, to Require the Accounting by Them of Fees, Costs and Charges Required by Law to Be Paid to the Treasurer of Said County to Make Such Accounting Prerequisite to Collection by Said Officers of Their Salaries, to Provide for the Preservation of Such Accounts and Records and to Make any Violation of Such Provisions a Misfeasance in Office and Ground for Removal and a Misdemeanor and to Provide the Punishment for Such Violation.

Whereas, under the general laws as well as under special provisions in the general laws, the Treasurer, Auditor, Clerk of Court, Judge of Probate, and Sheriff of Darlington County are entitled to collect certain fees, costs and charges, now, therefore,

Section 1. Certain Darlington County Officers to be Paid Salaries in Lieu of Fees.—Be it enacted by the General Assembly of the State of South Carolina: That in lieu of the retention of all said fees, costs and charges, and of any and all sums paid them on account of compensation or otherwise, the said officers of said County shall be paid such salaries as may be prescribed by the General Assembly and annually appropriated by it for such pur-

be paid into the fund. There shall also be paid into the fund all other Federal aid accruing or paid to the county for school purposes. The auditor shall levy and the treasurer shall collect 49 mills for school purposes on all taxable property of the county.

The Beaufort County Board of Education is authorized to expend out of funds on hand so much as may be necessary to pave driveways and parking areas at the various schools within the county. Such paving shall be done pursuant to contracts let by the South Carolina State Highway Department.

PART II

Permanent Provisions

SECTION 1

All purchases over two hundred dollars shall be made only with a purchase order approved by the county board of directors, or its duly authorized agent, after receipt of bids where practicable.

SECTION 2

The Beaufort County Board of Directors shall enter into an agreement or contract for the operation and maintenance of the county airports.

SECTION 3

The Beaufort County Board of Directors is authorized to maintain and construct roadside parks and litter deposit stations; and to enter into agreements with persons concerning the use of county landings so long as such agreements do not interfere with the public use of such landings.

SECTION 4

The County Board of Directors shall furnish to each operating department, under its jurisdiction, a monthly statement before the tenth day of each month, showing total expenditures made and balances remaining in each account.

SECTION 5

Before any road shall be accepted by the Board of Directors for maintenance by the county, deeds of rights of way therein shall be obtained, conveying rights of way, meeting at least the minimum requirements of the S. C. State Highway Department with respect to State secondary highways, and no paved road shall be accepted

An Act To Authorize The Beaufort County Board Of Directors To Lease Hangar Sites And Other Facilities At The Lady's Island Airport.

Be it enacted by the General Assembly of the State of South Carolina :

SECTION 1. Beaufort County may lease airport facilities at Lady's Island Airport.—The Beaufort County Board of Directors is authorized to enter into leases for periods not exceeding ten years for hangar sites at the Lady's Island Airport, and to enter into leases and agreements concerning the other facilities at the Airport for not more than three years.

SECTION 2. Time effective.—This act shall take effect upon approval by the Governor.
