tenths (258.5) feet to a point; thence northwest along the property of the said W. C. Cumbee and David H. Smith, a distance of three hundred seventy-nine (379) feet to the southwestern corner of a lot owned by David H. Smith; thence northeast along the property of David H. Smith, a distance of approximately three hundred and twenty-five (325) feet to a point on the northeastern side of said U. S. Highway No. 78 (also known as Fifth North Street); thence west along the northeast side of said U. S. Highway No. 78 (also known as Fifth North Street) to the point of beginning.

The proper proportion of the existing Charleston County indebtedness of the area so transferred shall be assumed by Dorchester County.

Transfer of Records

SECTION 2. Upon application, the clerk of court, register of mesne conveyances, sheriff and probate judge of Charleston County shall furnish certified copies of any judgment roll, entry on abstract of judgment book, will, record, execution, decree, deed, mortgage or other papers signed or recorded in the office of such officers, upon payment of proper fees and when such certified copy is filed or recorded in the proper office of Dorchester County, the same shall have the same force and effect in Dorchester County that it had in Charleston County and any record not so transferred shall continue in force and effect and each shall have the same force and effect in Dorchester County as if it had been transferred and made a record in the proper office in Dorchester County.

An Act To Remove A Portion Of Edisto Beach Recently Annexed To Colleton County And Areas Annexed To Dorchester County From The Charleston County Airport District.

Be it enacted by the General Assembly of the State of South Carolina:

Area removed from Charleston County Airport District

SECTION 1. The portion of Edisto Beach transferred to Colleton County by Act 81 of 1975 is removed from the Charleston County Airport District.

Further

SECTION 2. (1) The portion of Dorchester County transferred to Dorchester County from Charleston County pursuant to the provisions of an act of 1977 bearing ratification number 143 is hereby removed from the Charleston County Airport District.

(2) The portion of Dorchester County transferred to Dorchester County from Charleston County pursuant to the provisions of an act of 1977 bearing ratification number 150 is hereby removed from the Charleston County Airport District.

(3) The portion of Dorchester County transferred to Dorchester County from Charleston County pursuant to the provisions of an act of 1977 bearing ratification number 151 is hereby removed from the Charleston County Airport District.

An Act To Create The Dorchester County Aeronautics Commission; To Provide For Its Membership, Their Terms And Duties.

Be it enacted by the General Assembly of the State of South Carolina:

SECTION 1. Dorchester County Aeronautics Commission created.—There is hereby created the Dorchester County Aeronautics Commission which shall be composed of three members to be appointed by the legislative delegation for two-year terms. The commission shall cooperate with State and Federal agencies with the view of fostering aviation within the county.

SECTION 2. Time effective.—This act shall take effect upon approval by the Governor.

An Act To Create The Dorchester County Aeronautics Commission And To Repeal Act No. 958 Of 1962, Relating Thereto.

Be it enacted by the General Assembly of the State of South Carolina:

SECTION 1. Dorchester County Aeronautics Commission created.—The Dorchester County Aeronautics Commission is hereby created and shall consist of five members who are residents of the county and who shall be appointed by the governing body of the county.

SECTION 2. Terms and recording of names.—The terms of office of the members shall be for four years and until their successors are appointed and qualify. The chairman shall notify the Secretary of State of the names and terms of the members. All vacancies shall be filled in the manner of the original appointment for the unexpired portion of the term only.

SECTION 3. Compensation—chairman.—The members of the commission shall not receive any compensation for their services. The members shall each two years select one of their number as chairman of the commission. Nothing herein contained will prohibit the chairman from succeeding himself.

SECTION 4. May acquire property.—The commission may acquire by grant, purchase, lease, condemnation or otherwise real property and rights of way for airport and aeronautical purposes and approaches and obstruction rights for airport and aeronautical purposes. It may also sell, lease, trade, convey and exchange property and rights theretofore acquired for such purposes which in its opinion are not needed for the purposes for which they were acquired, with the approval of a majority of the county council. The manner of acquiring property by condemnation as authorized in this act may be such as is provided by law for the condemnation of rights of way for road purposes by the State Highway Department. The commission may receive by gift or donation moneys and other property to be used by it in carrying out the purposes of this act.

SECTION 5. May lease property.—The commission may lease to the United States of America or to any agency thereof or to any person, firm or corporation, municipal or private, any and all of the property and rights acquired by the commission under the provi-

sions of this act or under the provisions of any other act, statute or law. The commission may also enter into agreements with the United States of America or any agency thereof or any person, firm or corporation, municipal or private, relative to the establishment, operation and maintenance of an airport and aeronautical field in such county. All such leases and agreements shall be valid and binding upon the commission and the county.

SECTION 6. Powers to be additional.—The powers and authority extended to the commission under the provisions of this act shall be cumulative to and in addition to all powers and authorities the commission may have by virtue of the provisions of any other act, statute or law.

SECTION 7. Action to be taken in name of Dorchester County.—All property and rights received and acquired by the commission, all conveyances, leases and agreements made by it and all other acts of the commission under the provisions of this act or of any other act, statute or law shall be for and in behalf of and in the name of Dorchester County. All deeds, leases, agreements and all other papers executed by the commission shall be executed in the name of Dorchester County by the commission, and at least two members of the commission shall subscribe their names in the execution thereof.

SECTION 8. Airport fund.—All funds received by the commission shall be turned over to the treasurer of the county and by him placed in a special fund to be known as the "airport fund."

SECTION 9. Intent of act.—It is the intent of this act that the commission shall act for the county in all matters related to airports and aviation in the county and shall, in addition to the rights, powers and authorities set out in this act, have all the rights, powers and authorities extended and given to the counties in this State under the provisions of Article 1, Chapter 4, Title 2, Code of Laws of South Carolina, 1962, the Uniform Airports Act.

SECTION 10. Not to affect present members.—The provisions of this act shall not affect the terms of the present members of the commission.

SECTION 11. Repeal.—Act No. 958 of 1962 is repealed.

SECTION 12. Time effective.—This act shall take effect upon approval by the Governor.

An Act To Amend Sections 46-139 And 46-215, Code Of Laws Of South Carolina, 1962, Relating To The Definition Of A Bicycle, So As To Further Provide Therefor.

Be it enacted by the General Assembly of the State of South Carolina:

SECTION 1. Certain bicycles with motors defined as bicycles.

—The definition of a bicycle as defined in Item (2) of Section 46-139 and Section 46-215 of the 1962 Code shall include pedal bicycles with helper motors rated less than one brake horsepower transmitted by friction and not by gear or chain, which produce only ordinary pedaling speeds up to a maximum of twenty miles per hour.

SECTION 2. Time effective.—This act shall take effect upon approval by the Governor.
