**An Act To Repeal Article 14, Chapter 5, Title 2, Code Of Laws Of South Carolina, 1962, Relating To The Greenwood County Airport Commission.**

Whereas, the Governing Body of Greenwood County has requested the members of the General Assembly representing Greenwood County to abolish the Greenwood County Airport Commission; and

Whereas, the General Assembly determines that it is in the best interest of Greenwood County to abolish such commission. Now, therefore,

Be it enacted by the General Assembly of the State of South Carolina:

**SECTION 1. Repeal.**—Article 14, Chapter 5, Title 2, of the 1962 Code is hereby repealed.

**SECTION 2. Time effective.**—This act shall take effect upon approval by the Governor.

~~**An Act To Amend An Act Of 1976 Bearing Ratification No. 680 Relating To The Old Abbeville District Historical Commission, So As To Increase The Membership Thereof.**~~

~~Be it enacted by the General Assembly of the State of South Carolina:~~

~~**SECTION 1. Old Abbeville District Historical Commission.**—Section 1 of an act of 1976 bearing ratification No. 680 is amended on line three by striking "six" and inserting "nine" and by striking "three" and inserting "six" so that when amended the section shall read:~~

~~"Section 1. There is hereby created the Old Abbeville District Historical Commission for Abbeville, Greenwood and McCormick counties. The commission shall be composed of nine members, six of whom shall be appointed by the Governor on recommendation of the resident members of the Abbeville, Greenwood and McCormick counties legislative delegations. The appointed members of the commission shall serve four year terms and until their successors are~~

**AN ACT To Create An Airport Commission For The County And City Of Greenwood And To Provide For Its Duties.**

BE IT ENACTED by the General Assembly of the State of South Carolina:

**SECTION 1: Greenwood airport commission.**—There is hereby created the Greenwood Airport Commission which shall consist of three members, one appointed by the Mayor and a majority of the City Council of the City of Greenwood; one by the Senator and a majority of the Legislative Delegation of Greenwood County; and one by joint action of the Mayor and a majority of City Council and of the Senator and majority of the Legislative Delegation.

**SECTION 2: Terms.**—The initial term of the member appointed by the Mayor and City Council shall expire on May 1, 1950; that of the member appointed by the Senator and Legislative Delegation on May 1, 1949 and that of the other member on May 1, 1948. The regular terms of office shall be for periods of four years each from the expiration of the next preceding term.

**SECTION 3: Officers.**—The Commission shall elect from its membership a Chairman and a Secretary-Treasurer, each for a term of one year and until his successor has been elected and qualified.

**SECTION 4: Duties and powers of officers.**—The Chairman shall preside at meetings of the Commission, and give general supervision to the work of the Commission. The Secretary-Treasurer shall make and preserve permanent minutes of all meetings of the Commission and shall accept all funds made available to the Commissioner through rents or otherwise and shall deposit same in the name of the Commission, subject to the order of the Commission, in some solvent bank or banks of Greenwood County. No checks or drafts against the bank accounts of the Commission shall be honored or paid unless signed both by the Chairman and the Secretary-Treasurer.

**SECTION 5: Secretary-treasurer furnish bond.**—The Secretary-Treasurer shall, before assuming the duties of his office, deliver to the Finance Board of Greenwood County his fidelity bond with Corporate surety in the penal sum of One Thousand (\$1,000.00) Dollars, payable to Greenwood County and the City of Greenwood, in the form of other official bonds, subject to approval both as to

form and surety by the Finance Board of Greenwood County. After approval the said bond shall be recorded and filed in the Office of the Clerk of Court of Common Pleas. The Commission shall pay premiums on said bond.

**SECTION 6: Properties control—contracts.**—The Commission shall take charge of and manage the present Greenwood County Airport and any other Airports or landing fields which Greenwood County and the City of Greenwood may jointly acquire and shall make all necessary rules and regulations relative thereto. The Commission is authorized to disburse its funds and make contracts on such terms as it may deem expedient and to the best interest of the County and City relative to the use of such airports and landing fields and for the promotion of air transport for the County and City; **PROVIDED, HOWEVER,** the Commission shall not have authority to create obligations of Greenwood County or the City of Greenwood beyond the resources of the Commission.

**SECTION 7: Accounts—funds—audit—reports.**—The Commission shall keep its accounts and funds separate from those of the County and City but same shall be subject to inspection and audit by proper officials of the County and City at any time. The Commission shall prepare an annual report of its receipts and disbursements and for what purpose and an inventory of its assets and outstanding obligations and contracts as of July 1 at of each year and shall file copies thereof with the Clerk to the Finance Board of Greenwood County and the Clerk of the City of Greenwood on or before August 1st of each year.

**SECTION 8: Reimburse members for expenses.**—The Commission may reimburse its members for their actual expenses incurred on the business of the Commission.

**SECTION 9: Repeal.**—All Acts, or parts of Acts, inconsistent herewith are hereby repealed.

**SECTION 10: Time effective.**—This Act shall take effect upon its approval by the Governor.

**An Act To Terminate The Terms Of Office Of The Present Greenwood Airport Commission And To Amend Sections 2-321 And 2-322, Code Of Laws Of South Carolina, 1952, So As To Reconstitute The Commission And To Provide For Its Members And Their Terms Of Office.**

Be it enacted by the General Assembly of the State of South Carolina:

**SECTION 1. Terms of present Greenwood Airport Commission terminated.**—The terms of office of the present Greenwood Airport Commission are hereby terminated.

**SECTION 2. Section 2-321, 1952 Code, amended—Greenwood Airport Commission created—members.**—Section 2-321, Code of Laws of South Carolina, 1952, is amended to read as follows:

“Section 2-321. The Greenwood Airport Commission is hereby created to consist of five members. Two of its members shall be appointed by a majority of the City Council of Greenwood, including the Mayor; two shall be appointed by a majority of the Legislative Delegation of Greenwood County, including the Senator, and one shall be appointed jointly by a majority of the City Council of Greenwood, including the Mayor and a majority of the Greenwood County Legislative Delegation, including the Senator.”

**SECTION 3. Section 2-322, 1952 Code, amended—terms.**—Section 2-322, Code of Laws of South Carolina, 1952, is amended to read as follows:

“Section 2-322. Of the members appointed initially, two shall be appointed for a term of two years and three for a term of four years, after which their successors shall be appointed for regular terms of four years each or until their successors are appointed and qualify.”

**SECTION 4. Repeal.**—All acts or parts of acts inconsistent herewith are repealed.

**SECTION 5. Time effective.**—This act shall take effect upon approval by the Governor.
