AN ACT To Create An Airport Commission For The County And City Of McCormick And To Provide For Its Duties, And Prescribe The Terms Of Office Of The Members Thereof.

BE IT ENACTED by the General Assembly of the State of South Carolina:

SECTION 1: McCormick airport commission — appointment.—

There is hereby created the McCormick Airport Commission for the County and City of McCormick, which shall consist of three (3) members, two (2) to be appointed by the Legislative Delegation of McCormick County, and one (1) by the City Council of the City of McCormick.

SECTION 2: Duties and powers.—Said Commission shall have full power and authority to manage the McCormick Airport and to make all necessary rules and regulations thereabout, with the Federal Government; shall generally assist the Federal Government in matters arising concerning said airport and shall have general supervision and control with the Federal Government and in accord with all contracts hereafter made.

SECTION 3: Term—vacancy—qualification.—That the term of office of each commissioner shall be for a period of four (4) years and until his successor shall have been appointed and qualified. In

case of a vacancy in the membership of said commission, a person shall be appointed for the unexpired term to fill such vacancy. Such person shall be appointed in like manner as his predecessor was appointed. The qualification of each commissioner shall be by his written consent to act as such commissioner.

SECTION 4: Repeal.—All Acts or parts of Acts inconsistent with the provisions of this Act are hereby repealed.

SECTION 5: Time effective.—This Act shall take effect upon its approval by the Governor.

AN ACT To Provide For The Organization, Duties, And Powers Of The City Board Of Education Of School District No. 17 Of The City Of Sumter By Striking Out Section 5659-1 (5), And Substituting In Lieu Thereof A Further Provision With Reference To The Powers Of Said Board.

BE IT ENACTED by the General Assembly of the State of South Carolina:

SECTION 1. § 5659-1, 1942 Code, amended—city board of education, School district of the city of Sumter—meetings—officers and employees—limitations on members—duties and powers.—That Section 5659-1 (5), Code of laws of South Carolina, 1942, be, and the same is hereby amended by striking out all of said Section and inserting in lieu thereof the following, which shall be known as Section 5659-1 (5):

“Section 5659-1 (5): The seven school commissioners elected as provided for in subsection 4 shall constitute the said school board which shall be known as the ‘City Board of Education.’”

The said board may assemble at any time and shall elect a chairman, a vice-chairman, a secretary-treasurer, a superintendent of schools, and such other school employees as they may deem proper, whose term of office, duties and compensation shall be prescribed by said board: PROVIDED, That no member of the said Board shall be eligible to any salary office within the provisions of this Section,
